## Section 1: Canada Harmonized Tariff Schedule (HTS#)

### **1.1 Canada HTS#**

For FCA U.S. Terms of Sale where Nordstrom Imports, Suppliers must provide either Canadian HTS numbers OR detailed product specifications via Nordstrom Spec Sheet for each item.

It is not enough to provide just U.S. HTS or a 6-digit export number to Nordstrom Canada. If Nordstrom is the importer, suppliers must choose and comply with CA HTS or Spec Sheet.

Canadian HTS# can be obtained by:

- 1) Leveraging your current U.S. HTS classifier to assign CA HTS at the same time. This is the most efficient option for all parties.
- 2) Contacting a Canadian or U.S. customs broker for CA HTS assistance. This is a good option for U.S. manufacturers who have not imported or exported.
- 3) Referencing the Canada Border Services Agency(CBSA) Customs Tariff:

Suppliers should provide the CA HTS # in NuOrder or on the IIF provided by the Buying Office for item set up.

### **1.2 Detailed Product ‘Spec Sheet’**

If suppliers are unable or unwilling to provide Canada HTS#, then suppliers must complete the Nordstrom Specification Sheet (‘Spec Sheet’) providing detailed product specifications. At time of item-set up, Merchandise Information will email suppliers a Spec Sheet to complete.

The Spec Sheet will be pre-populated with Vendor’s Product Number and Nordstrom’s RMS #. It contains various drop-down menus and free-form fields for suppliers to provide enough item characteristics so a Canada HTS# can be assigned. Any delay in providing complete and accurate product specifications may result in order cancellation or import/delivery delays.
